- To encourage and support its teaching staff for academic growth and career advancement.




Policy Statements

- Faculty members intending to avail financial support must follow the application process.
- Complete and submit a filled copy of the application for reimbursement of expenses or availing incentives in the prescribed form, to the Principal.
- Applications must be submitted within the specified time frame, as communicated in the yearly notifications.
- A maximum of Rs 10,000 per person in a year will be provided as an incentive for chairing, handling sessions as a resource person, presenting papers, or participating at eligible programs.
- Financial support will also be provided towards membership fees for professional bodies.
- In special cases where the nature or significance of the program warrants additional support, higher amounts may be considered upon approval by the competent authority.
- This policy is subject to periodic review and updates as deemed necessary by the competent authority.

Additionally, periodic reviews and updates to financial support policies is done by the institution by discussing college council, IQAC with evolving needs and priorities within the educational institution.
